## ANNO REGNI VICESIMO NONO VICTORIYE REGINAE.

JAMAICA, ss.

CAP. XVII. [22 Dec 1865]

An act to continue, for a limited period, the several expiring acts therein mentioned, and for other purposes.

BE it enacted by the governor, legislative council, and assembly V of this island, and by the authority of the same, as follows:

First – The several undermentioned acts of the legislature of this island, being about to expire, are and each of them is hereby continued in force from the respective date at which each of them would expire, until the thirty-first day of December, one thousand eight hundred and sixty-six; that is to say,

undermentioned The expiring acts continued in force viz

"The Police Act, one thousand eight hundred and sixty-one," of the Police twenty-fourth Victoria, chapter eleven.

"The Post-Office Act, one thousand eight hundred and sixty-two," of Post office the twenty-sixth Victoria, session one, chapter seven.

"The act to reduce the amount of the security to be given by the secretary of this island, and for other purposes. Of the twenty-seventh Victoria, session two, chapter one.

Reduction of island secreatary's security

"The act to revive and continue in force, for a limited period the acts of the twenty-sixth Victoria, chapter thirteen and the twenty-fifth Victoria, chapter forty-two (Insolvent Debtors' Law), and for other purposes£ of the twenty-seventh Victoria, session two, chapter two.

Insolvent debtors

And "the act to provide for the registrar in chancery and clerk of the patents an annual salary in lieu of fees.

Register in chancery

Second – The additional junior sergeant, and nineteen additional privates of Police, appointed, or to be appointed for the city of Kingston, shall be paid at the like rates of pay respectively as are authorized, and have the powers and authorities and be subject to the provisions of the "Police Act, one thousand eight hundred and sixty-one;" and the water-police employed, and to he employed in aid of the Kingston division of police, shall have the like powers and authorities, and be subject to the like provisions of the said "Police Act, one thousand eight hundred and sixty-one."

Payment of additional sergeants and privates of Kingston police

Third – Notwithstanding anything to the contrary in the act of the twentyeighth Victoria, chapter thirty-two, to provide fur the registrar in chancery and clerk of the patents an annual salary in lieu of fees, there shall not be any stamps impressed on any writ of election for any member of the legislature, nor any patent of pardon.

Exemption of certain stamp duty on writs of election and patents of pardon.

## Jamaica Post Office Act of 1865

Fourth - That in case of any new appointment to the office of registrar in New appointment of chancery, any person who shall be appointed to such office, shall take the registrar of chancery same, subject to any amalgamation of that office with any other, on the abolition thereof, or with any such emolument as the legislature may determine.
