AMENDED RULE MADE BY THE POSTMASTER FOR JAMAICA UNDER SECTION 6 OF LAW 1 OF 1879, "THE TELEGRAPH LAW, 1879."

1. The charge for telegrams throughout Jamaica is Ninepence for any number of words up to twelve, and a halfpenny for every additional word, all that the sender writes is to be counted, including the address and signature.

All charges, including porterage and prepayment of reply, must be prepaid by postage stamps, affixed by the sender. As few stamps as possible must be used to make up the total amount. The rate for press messages is Ninepence for the first twenty-four words and a half penny for every additional two words.

Every parcel post packet addressed to the United Kingdom or any of His Majesty's Colonies or Dominions will bear an extra tax of 3d. Except such parcels as are addressed to members of His Majesty's Navy or Army.

Parcels - Incoming.

On every parcel or parcel post packet containing dutiable matter arriving in the island through the post a tax of 3d will be collected. A special overprinted half penny and three penny stamps will be issued for the purpose, but in the event of such a stamp not being available the ordinary half penny stamp may be used.
