JAMAICA Law No. 1. - 1917

A LAW to continue various expiring Laws and to amend certain of those Laws.

WHEREWHEREAS the Laws mentioned in Part I of the AS Schedule to this Law are limited to expire in their entirety on the thirty-first day of March nineteen hundred and seventeen and the Law mentioned in Part II of that Schedule is limited to expire on the said date with respect to the increased duty thereby imposed on Rum, Beer, Matches, Cigars and Pipe Tobacco:

Preamble

And whereas it is expedient to provide for the continuance as in this Law mentioned of those Laws.

Be it enacted by the Governor and Legislative Council of Jamaica, as follows:—

1--This Law may be cited as the Expiring Laws Continuance Law, 1917.

Short Title

- 2—The Laws mentioned in the Schedule to this Law shall to the extent specified in column 3 of that Schedule be continued until and including, the thirty-first day of March nineteen hundred and eighteen.
- Continuance of Laws specified in column 3 of Schedule to this law
- 3—The words "and post card" in Section 3 (1) of the Post Office (War Tax) Law, 1916 (Law 8 of 1916) are hereby repealed as from the nineteenth day of October nineteen hundred and sixteen.

Certain words in section 3 (1) of Law 8 of 1916 repealed as from October 19th 1916.

4—There shall be added to section 3 of the Licences (Temporary Surtax) Law, 1916 (Law 6 of 1916), the following sub-sections which shall take effect as from the first day of April, 1916:-

Addition to Section 3 of Law 6 of 1916

- " (3) The surtax hereby imposed shall be payable " in respect of any Licence granted or issued or "coming into operation during the continuance in "farce of this Law."
- "(4) The Collector General may make a refund of "any amount which in his opinion has been over-"paid under this Law."
- 5 -There shall be substituted for the Schedule to the Export (Temporary War Duties) Law, 1916 (Law 1 of 1916) the following Schedule that is to say :—

6—The substitution of the words "dry or dry salted" for the word "dry" in the Schedule to Law 1 of 1916 and the substitution of the words "green or wet salted" for the word "green" in the said Schedule shall take effect as from the first day of April, 1916.
