Stamp Office, Kingston, 23rd April, 1937.

The following is a description of the Postage and Revenue Stamps (1d.,  $1\frac{1}{2}$ d. and  $2\frac{1}{2}$ d.) which will be put into circulation on 12th May 1937 to commemorate the Coronation of His Majesty King George

VI.

The design of the stamps includes portraits of Coronation Emblems, including the Crown, Orb, Sword of State and Sceptre.

The Stamps are printed from steel plates engraved in recess. The date of the Coronation, 12th May, 1937, is shown at the top of the Stamps.

The duties, 1d.,  $1\frac{1}{2}d.$  and  $2\frac{1}{2}d.$  are shown respectively on labels at the right and left corners at the bottom of each stamp. The name of the Colony, JAMAICA, is shown between the duty labels.

The colour of the 1d. stamp is red, that of the  $1\frac{1}{2}$ d. grey and that of the  $2\frac{1}{2}$ d. blue. C. C. Manton,
