(c) any postcard with address label or slip to fold back and adhere to the postcard for address purposes or any postcard consisting of a folded sheet of paper completely gummed together on the inner sides or any postal packet the envelope whereof has been adapted for re-use by means of a gummed slip or tape affixed thereto or has a gummed label (other than an official service label) affixed thereto for any purpose other than that of an address label.

3—The provisions of paragraph 2 of this Order shall not apply to the despatch of any postal packet—

(a) by a person who has previously obtained a permit for the purpose issued by or on behalf of the Chief Censor and has complied with any conditions subject to which the permit has been granted;

(b) on His Maiesty's Service or on that of a Government Department of the United Kingdom or the

(b) on His Majesty's Service or on that of a Government Department of the United Kingdom or the Government of Northern Ireland or of any of His Majesty's Colonies, Protectorates or Mandated territories, or a High Commissioner for one of the Dominions, or for India, Burma or Southern Rhodesia, or an Agent-General for one of the Australian States;

(c) on the official service of the Chief Diplomatic Representative in the United Kingdom of a foreign power or of a Consul General of a foreign power in any of His Majesty's Dominions, Colonies

or Mandated territories;



#### THE UNITED STATES (MILITARY BASES) PROTECTED AREA ORDER, 1942.

WHEREAS I am satisfied that it is necessary or expedient in the interest of defence or the efficient prosecution

Whereas I am satisfied that it is necessary or expedient in the interest of defence or the efficient prosecution of the war so to do:

Now Therefore, in the exercise of the powers conferred upon me by Regulation 33 of the Jamaica Defence Regulations, 1940, and every other power hereunto enabling, I do hereby order as follows:—

1—This Order may be cited as the United States (Military Bases) Protected Area Order, 1942, and shall come into operation on the day of its publication in the Gazette.

2—The respective areas specified in the Schedule to this Order are hereby constituted Protected Areas for the purpose of the above Regulations.

3—No enemy alien shall be within any such area.

4—(1) No person shall be within any area constituted a Protected Area under this Order except—

(a) he was resident within such area at the commencement of the day of the coming into operation of this Order; or

(b) he is a member of the armed forces of the United States; or

(c) he is in lawful possession of a permit to be within such area; or

(b) he is a member of the armed forces of the United States; or
(c) he is in lawful possession of a permit to be within such area; or
(d) he is the holder of a pass issued by or on behalf of the Competent Authority.
(2) In sub-paragraph (1) of this paragraph—
"pass" means any written document authorising any person to enter either any one area constituted a Protected Area under this Order or all such areas;
"permit" means any token, badge, emblem, ticket, or time-card, issued by or with the approval of the Competent Authority for the purpose of identifying the holder as a person employed within any area constituted a Protected Area under this Order.
(3) No person shall be deemed to be in lawful possession of any permit—
(a) if such permit was not issued to him; or
(b) if he has retained such permit after having been required by the Competent Authority, or any

(a) If such permit was not issued to him; or
(b) if he has retained such permit after having been required by the Competent Authority, or any person authorised in that behalf, to deliver it up; or
(c) at any time when he is within any part of the area in respect of which such permit was issued otherwise than for purposes arising out of, and in the course of, his employment; or
(d) at any time when he is not wearing, displaying, or carrying, such permit in the manner required by the Competent Authority.



(b) any other postal article containing shipping information on the outside thereof.

(3) Any person desiring to send from Jamaica to a person outside Jamaica a telegram containing shipping information shall keep the telegram in a closed envelope until it is submitted for censorship and shall submit it for censorship to the Censor of postal matter and telegrams. No person shall open any envelope containing shipping information unless it is first submitted, duly stamped, for censorship to the Censor of postal matter and telegrams. No person shall open any such postal article after it has been censored."
