(under Section 2 (3) of the above Law.)

(Law 60 of 1941.)

ORDER

(under Section 7 of the above Law.)

In exercise of the powers conferred upon me by Section 7 of the above Law and of every other power hereunto enabling I, the Postmaster General, hereby ORDER as follows:

(1) This Order may be cited as the Post Office (Rate of Postage) (Amendment) (No. 2) Order, 1942, and shall be read and construed as one with the Order made under the Post Office Law and published at page 245 of the Jamaica Gazette Supplement of the 28th day of May, 1942, (hereinafter referred to as the principal Order) and all amendments thereto.

(2) The principal Order is hereby amended by the deletion of the figure and letter "6d." (where they appear opposite to the word "Canada") from Section (XII) of the Schedule thereto and the substitution therefor of the words "One Shilling".

(3) That this Order shall take effect as and from the first day of August, 1942.

(under Section 7 of the above Law.)

In exercise of the power conferred upon me by Section 7 of the above Law and of every other power hereunto enabling, I, the Postmaster General, hereby ORDER as follows:

1. This Order may be cited as the Post Office (Rate of Postage) (Amendment) Order, 1942, and shall be read and construed as one with the Order made under the Post Office Law and published at page 245 of the Jamaica Gazette Supplement of the 28th day of May, 1942, (hereinafter referred to as the principal Order).

2. The principal Order is hereby amended by the deletion of that portion of the Schedule thereto which fixes the postage rate on parcels under the heading "Inland Postage" and by the substitution therefor of the following:—

Parcel- Post Parcels for the first pound
Three Pence and for every additional pound or fractional part thereof Two Pence

3. This Order shall take effect as and from the first day of August, 1942.
