THE TELEGRAPH CONTROL LAW,

(Cap. 247)

The Telegraph Control (Amendment) Regulations, 1943

In exercise of the powers conferred upon the Governor in Privy Council by section 3 of the Telegraph Control Law, the following Regulations are hereby made:—

1. These Regulations may be cited as the Telegraph Control (Amendment) Regulations, 1943, and shall be read and construed as one with the Regulations made by the Governor in Privy Council on the 16th day of August, 1938, and published in the Gazette of the 29th day of September, 1938, hereinafter referred to as the principal Regulations.

2. The principal Regulations are hereby amended in the following respects:—

(a) by the insertion before Regulation 1 of the following as Regulation 1A:

"1A—These Regulations may be cited as the Telegraph Control Regulations, 1938."

(b) by the addition at the end of Regulation 1 of the following proviso:—
"Provided further that no foreign consul-general, consul, vice-consul or consular agent de carriere representing in Jamaica any country in respect of which reciprocal arrangements are in force shall be required to pay any fee for the maintenance or use of any wireless receiving apparatus."

THE SOCIAL GREETING TELEGRAMS (PROHIBITION) ORDER, 1943

In exercise of the powers conferred upon me by Rule 1AB of the Telegraph Rules, 1933 (as inserted therein by the Telegraph (Amendment) Rules, 1943), I do hereby make the following Order:-

1. This Order may be cited as the Social Greeting Telegrams (Prohibition)

Order, 1943.

2. No person shall send any social greeting telegram between the 18th day of December, 1943, and the 3rd day of January, 1944.

3. In this Order "social greeting telegram" means any telegram containing any greetings, congratulations or good wishes.
