## 9 Oct 1944; Introduction of Air Letter [Gleaner 9 Oct 1944]

### LIGHT -WEIGHT AIR LETTERS

A special service of lightweight "air letters" available for communication (1) with personnel of His Majesty's Forces and merchant ships in all countries to which an air mail service is available and (2) with, civilian addresses in certain of those countries only, has been announced by the Postmaster General of Britain. It is believed that a similar service may be introduced In Jamaica but it is not yet known when this will take place.

Particulars of the service Issued in a British Post Office Circular, show that air letters will normally be conveyed by air throughout to the country of destination, but where all-air transmission is not possible, air letters are sent by the quickest available route.

The air letter must be written on a special form which will be available, in countries where the service is in operation, from any Post Office, price 6d., including postage. The air letter when folded and sealed. form a closed communication designed to conserve aircraft capacity; no other type of form can be accepted, and nothing may he enclosed, otherwise the letter will be sent by ordinary mail.

## 27 Nov 1944; Introduction of Air Letter [Gleaner 23 Nov 1944]

#### **NOTICE**

Effective Monday November 27, 1944, airmail letters written on the special light-weight air letter forms will be accepted for all-air transmission to any place in the British Empire for 6d each.

The British Post Office has as an exceptional measure supplied this Administration with a stock of these forms and these will be sold with a 6d stamp affixed thereto all Post Offices. When this stock of special air-letter forms is exhausted the public must purchase privately manufactured air-letter forms of the identical size and weight as the official form from the local bookshops and store. These will be accepted for transmission at 6d each
