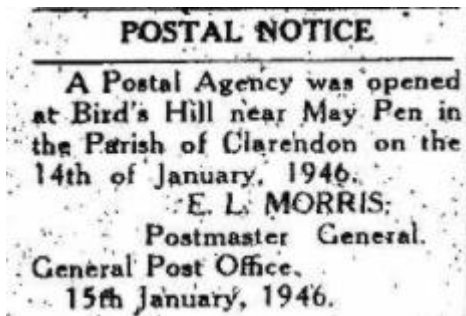

GREETING

Whereas by the Tenth Clause of the Jamaica Letters Patent 1944 the Governor is empowered to constitute and appoint all such Judges and other Officers as may lawfully be constituted or appointed by the Sovereign:

And whereas by section 2 of the Cayman Islands Commissioner's Law the Governor is empowered to appoint an Officer to administer the affairs of the Cayman Islands to be called the Commissioner:

And whereas Ivor Otterbein Smith Esquire has been appointed to exercise the functions of such Commissioner with effect from the 27th day of May, 1946:

And whereas it is considered expedient to make provision for the said Office of Commissioner in case of the absence at any time hereafter and from time to time of the Commissioner of the said Islands for the time being:

Now therefore, I the Captain-General and Governor-in-Chief of the Island of Jamaica and its Dependencies in pursuance of the power and authority in me vested do hereby appoint you the said Albert Colonridge Panton Esquire, Assistant Treasurer,

Collector of Customs, Postmaster and Justice of the Peace, Grand Cayman, to exercise the Office of Commissioner of the said Islands hereafter from time to time in case of the death, absence from the said Islands, retirement or incapacity of the said Ivor Otterbein Smith Esquire and in such only cases and until other provision shall be made therefor.

Given under my hand and the Broad Seal of the Island at King's House, Jamaica, this 29th day of June, in the year of Our Lord one thousand nine hundred and forty-six and in the Tenth Year of the Reign of His Majesty King George VI.

THE TELEGRAPH LAW

(Cap. 246)

THE SOCIAL GREETING TELEGRAMS (PROHIBITION) ORDER, 1946

In exercise of the powers conferred upon me by Rule 1 AB of the Telegraph Rules, 1933 (as inserted therein by the Telegraph (Amendment) Rules, 1943), I do hereby make the following Order:—

1. This Order may be cited as the Social Greeting Telegrams (Prohibition) Order, 1946.
2. No person shall send any inland social greeting telegram between the 18th day of December, 1946, and the 3rd day of January, 1947.
3. In this Order "Social greeting telegram" means any telegram containing any greetings, congratulations, or good wishes.
