

THE TELEGRAPH (AMENDMENT) RULES, 1948

In exercise of the powers conferred upon the Governor in Executive Council by section. 7 of the Telegraph Law the following rules made on the 16th day of December, 1948, by the Postmaster General under section 7 of the said Law are hereby approved:—
