A LAW to Amend the Stamp Duty Law.

[26th July, 1948]

ENACTED by the Governor of Jamaica with the advice and consent of the Legislative Council and House of Representatives.

A LAW to Further Amend the Stamp Duty Law.

[18th November, 1949]

ENACTED by the Governor of Jamaica with the advice and consent of the Legislative Council and House of Representatives.

1—This Law may be cited as the Stamp Duty (Amend- Short title ment) (No. 2) Law, 1949, and shall be read and construed as struction. one with the Stamp Duty Law (hereinafter referred to as the Cap. 197. principal Law) and all amendments thereto.

2—The Schedule to the principal Law (as amended by Amendment the Stamp Duty (Amendment) (No. 2) Law, 1940) is hereby of principal amended in the following respects—

(a) by the deletion under the heading "Letters" of 1940 the following words and figures—

"On every letter or other instrument submitted by any person for the purpose of obtaining a right to enter for, or participate in, any competition (other than a sweepstake conducted in accordance with the provisions of section 33 of the Gambling Law) in connection with which a prize or prizes is or are offered (whether in money or any other form) in respect of every threepence or fractional part of threepence of any entrance fee, stake, contribution or subscription payable for or in connection with such right to enter or to participate ... 0 0 1 (such duty may be denoted by adhesive stamps)"

and by the substitution therefor of the following-

"On every letter or other instrument submitted by any person for the purpose of obtaining a right to enter for, or participate in, any competition (other than a sweepstake conducted in accordance with the provisions of section 33 of the Gambling Law) in connection with which a prize or prizes is or are offered (whether in money or any other form), in respect of every threepence or fractional part of threepence of any entrance fee, stake, contribution, or subscription, payable for or in connection with such right to enter or to participate, a duty thereon to be paid by the promoters of such competition ... 0 0 2".
