It is hereby notified that His Excellency the Governor, on the 19th day of July, 1950, gave his Assent to the following Laws, passed by the Jamaica House of Representatives and the Legislative Council of Jamaica, viz.:-

Law 22 of 1950 entitled "The Stamp Duty (Bills of Exchange) (Higher Rate) Law, 1950"; Law 23 of 1950 entitled "The Statistics (Amendment) Law, 1950"; Law 24 of 1950 entitled "The Kew Factory (Disposal of Canes) Law, 1950";

and on the 20th day of July, 1950, gave his Assent to the following Laws:—

Law 25 of 1950 entitled "The British Nationality (Fees and Penalties) Law, 1950";

Law 26 of 1950 entitled "The Arthur Carlyle Paton (Validation of Acts) Law, 1950".

A LAW to Amend the Stamp Duty Law.

[The date of any Proclamation issued by the Governor bringing the Law into operation.]

ENACTED by the Governor of Jamaica with the advice and consent of the Legislative Council and House of Representatives.

1-This Law may be cited as the Stamp Duty (Bills of short title Exchange) (Higher Rate) Law, 1950, and shall be read struction. and construed as one with the Stamp Duty Law (herein- cap. 197. after referred to as the principal Law) and all amendments thereto, and shall come into operation on a date to be appointed by the Governor by Proclamation published in the Gazette.

2-The Schedule to the principal Law is hereby amended Amendment by the deletion under the heading "BILLS OF EXCHANGE of Schedule to principal AND PROMISSORY NOTES (INLAND)" of the following words Law. and figures-

"Bills of exchange payable on demand and the substitution therefor of the following—

"Bills of exchange payable on demand £0 0

Additional duty may be denoted by affixing adhesive stamps to bills of exchange stamped before commencement of Law. 3—After the commencement of this Law any person who draws any bill of exchange payable on demand upon paper stamped before such commencement may denote the payment of the additional duty imposed by this Law by affixing to such stamped paper one or more adhesive stamps to the value of the difference between the stamp duty required under this Law to be borne by such bill of exchange and the stamp duty impressed thereon, so, however, that the person who affixes any adhesive stamps to any bill of exchange pursuant to this section shall at the time of so affixing such stamps write upon such stamps his initials and the date upon which they are so affixed and thereupon such stamps shall be deemed to be cancelled.

A LAW Further to Amend the Stamp Duty Law.

ENACTED by the Governor of Jamaica with the advice and consent of the Legislative Council and House of Representatives.

1—This Law may be cited as the Stamp Duty (Bills of Short title. Exchange) (Higher Rate) (No. 2) Law, 1950, and shall be and comread and construed as one with the Stamp Duty Law (hereinafter referred to as the principal Law) and all amend- Cap. 197. ments thereto, and, except as otherwise provided in section 4 of this Law, shall come into operation on a date to be appointed by the Governor by Proclamation published in the Gazette.

2—The Schedule to the principal Law is hereby amended Amendment by the deletion under the heading "BILLS OF EXCHANGE AND to principal PROMISSORY NOTES (INLAND)" of the following words and figures-

"Bills of exchange payable on demand ... £0 and the substitution therefor of the following-

"Bills of exchange payable on demand ... £0 0 4",

Additional duty may be denoted by affixing adhesive stamps to bills of ex. change stamped before commencement of Law.

3—After the commencement of this Law any person who draws any bill of exchange payable on demand upon paper stamped before such commencement may denote the payment of the additional duty imposed by this Law by affixing to such stamped paper one or more adhesive stamps to the value of the difference between the stamp duty required under this Law to be borne by such bill of exchange and the stamp duty impressed thereon, so, however, that the person who affixes any adhesive stamps to any bill of exchange pursuant to this section shall at the time of so affixing such stamps write upon such stamps his initials and the date upon which they are so affixed and thereupon such stamps shall be deemed to be cancelled.

Repeal of Law 22 of 1950.

- 4—(1) The Stamp Duty (Bills of Exchange) (Higher Rate) Law, 1950, is hereby repealed.
 - (2) This section shall come into operation forthwith.

MEMORANDUM OF OBJECTS AND REASONS

This Bill is designed to raise additional revenue by increasing the stamp duty payable upon bills of exchange payable on demand.
