(Law 60 of 1941)

THE POST OFFICE (RATES OF POSTAGE) (AMENDMENT) (NO. 3) ORDER, 1950

In exercise of the powers conferred upon the Governor in Executive Council by section 7 of the Post Office Law, 1941, the following Order made on the 1st day of December, 1950, by the Postmaster General under sub-section 2 of the said section 7 of the Post Office Law, 1941, is hereby approved:—

1—This Order may be cited as the Post Office (Rates of Postage) (Amendment) (No. 3) Order, 1950, and shall be read and construed as one with the Order made by the Postmaster General under the Post Office Law, 1941, and published in the Jamaica Gazette of the 28th day of May, 1942, at pages 245 to 255, inclusive, (hereinafter referred to as the principal Order) and all amendments thereto.

2—This Order shall come into force on the 1st day of January, 1951.

3—The Schedule to the principal Order is hereby amended by the deletion therefrom of Item (XI) inserted therein by the Post Office (Rates of Postage) (Amendment) Order, 1949, and the substitution therefor of the following:—
