The following is a description of the Scout Jamones Commemorative Issue of Postage and Revenue Stamps which will be on sale at all Postal Agencies and Post Offices on Wednesday, the fifth day of March, 1952.

"2d. DENOMINATION"

The Scouts' Badge, the Fleur-de-lis, appears in the middle lower part of the stamp forming the frame of a map of the West Indian Islands, parts of North, Central and South America in black with the Atlantic Ocean, the Facilic Ocean and the Caribbean Sea in blue.

Symbolical rays in green stream in all directions from this Fleur de-lis; these rays are halted towards the top of the stamp on the left hand side by an oval frame containing a full face picture of His Majesty, the late King George VI, and as for the remainder of the stamp by a segment of a circle; the stamp above this segment being green in colour likewise.

Beside the frame with the late King's head appears the colony name "JAMAICA" in a label with a crown immediately below.

On the left side of the Fleur-de-lis and near the bottom of the stamp is a bunch of bananas and on the right a bunch of citrus fruit. Two pieces of sugar cane form a frame at the bottom of the stamp which is divided by the lower end of the Fleur-de-lis. On the left side of this frame appear the words and figures "Ist Cammusan Jamuorez 1952" and on the right side of the frame the shield shaped denomination label "2d."

"6d. DENOMINATION"

The Stamp which is a reddish magenta in colour is enclosed in a black segmented border; in the centre of the stamp appears a map of the island of Jamaica in green, with the Scouts' Badge, the Fleur-de-lis, in black and superimposed thereon at the top, the words, 'Ba Pragaugn' appear in the usual place under the Fleur-de-lis. The eastern end of the Island is in turn superimposed on a circle which contains in black a map of the Western Hemisphere and above this circle is the san with rays streaming therefrom for a short distance.

A full face picture of the head of His Majesty, the late King George VI, appears in an oval frame impinging on the border at the upper left corner of the stamp with a crown in the right corner, between these the colony name "Jamaica" appears in a label.

Between the denomination labels "6d." at lower corners of the stamp are the words and figures in a label "1st Cardinera Jamborer 1952" and above the denomination label on the left side are a bunch of bananas, a pincapple and two citrus fruits and over the right label sngar cane.

The stamps will be in issue for three months or until supplies are exhausted whichever first may happen.


