THE POST OFFICE (BRITISH POSTAL ORDERS) (RATES OF POUNDAGE) ORDER, 1952

In exercise of the powers conferred upon the Governor in Executive Council by section 7 of the Post Office Law, 1941, the following Order made on the 6th day of August, 1952, by the Postmaster General under sub-section (2) of section 7 of the Post Office Law, 1941, is hereby approved:—

- 1. This Order may be cited as the Post Office (British Postal Orders) (Rates of Poundage) Order, 1952.
- 2. From and after the 1st day of September, 1952, British Postal Orders shall be subject to the following rates of poundage—

for each Postal Order at 6d. ... $1\frac{1}{2}d$. for each Postal Order at 1/- ... 2d.

for each Postal Order at 1/6, 2/-, 2/6, 3/-, 3/6, 4/-,

4/6, 5/- ... $2\frac{1}{2}d$.

for each Postal Order at 7/6, 8/-, 10/- ... 4d. for each Postal Order at 20/- ... 6d.

3. Item 14 of the Schedule to the Order made by the Postmaster General under the Post Office Law, 1941, and published in the Jamaica Gazette Supplement (Proclamations, Rules and Regulations) on the 28th day of May, 1942, at page 255 is hereby revoked as from the 1st day of September, 1952.
