THE POST OFFICE LAW

(Cap. 301)

THE POST OFFICE (RATES OF POSTAGE) (AMENDMENT) (NO. 3) ORDER, 1956

In exercise of the powers conferred upon the Governor in Executive Council by section 7 of the Post Office Law, the following Order made on the 18th day of April, 1956 by the Postmaster General under subsection (2) of the said section 7 of the Post Office Law is hereby approved:—

THE POST OFFICE LAW

(Cap. 301)

THE POST OFFICE (RATES OF POSTAGE) (AMENDMENT) (NO. 3) ORDER, 1956

In exercise of the powers conferred on the Postmaster General under subsection (2) of section 7 of the Post Office Law, the following Order is hereby made:—

1. This Order may be cited as the Post Office (Rates of Postage) (Amendment) (No. 3) Order, 1956 and shall be read and construed as one with the Order made by the Postmaster General under the Post Office Law, 1941, and published in the Jamaica Gazette Supplement of the 28th day of May, 1942 at pages 245 to 255 inclusive (hereinafter referred to as the principal Order) and all amendments thereto.

2. This Order shall come into force on the 1st day of June, 1956.

3. The schedule to the principal Order is hereby amended under the heading "Schedule of Air Mail Rates" as follows:—

(a) By deleting the words "and Post Cards" from the column headed "Letters and Post Cards Rate per $\frac{1}{2}$ oz."

(b) By inserting between the column abovementioned and the column headed "Air Letters" a new column headed "Post Cards" with the rates set out on the right hereunder each such rate to correspond with the destination appearing opposite thereto on the left hereunder:—
