**THE POST OFFICE LAW**

(Cap. 301)

**THE POST OFFICE (RATES OF POSTAGE) (AMENDMENT) (NO. 5) ORDER, 1956**

In exercise of the powers conferred upon the Governor in Executive Council by section 7 of the Post Office Law, the following Order made on the 11th day of October, 1956, by the Postmaster General under subsection (2) of section 7 of the said Law is hereby approved:—

1. This Order may be cited as the Post Office (Rates of Postage) (Amendment) (No. 5) Order, 1956, and shall be read and construed as one with the Order made by the Postmaster General under the Post Office Law, 1941, and published in the Jamaica Gazette Supplement of the 28th day of May, 1942, at pages 245 to 255 inclusive (hereinafter referred to as the principal Order) and all amendments thereto.

2. This Order shall come into force on the 19th day of November, 1956.

3. The Schedule to the principal Order is hereby amended by adding thereto, in the column headed "Parcels per  $\frac{1}{2}$  lb", under the heading "SCHEDULE OF AIR MAIL RATES", the rates set out on the right hereunder, each such rate to correspond with the destination appearing opposite thereto on the left hereunder:—
