#### THE STAMP ISSUES (CANCELLATION) LAW

Chapter 367 (Sec. 3 (1))

#### A PROCLAMATION



J. M. Srow, Acting Governor By His Excellency John Montague Stow, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Captain-General and Governor-in-Chief in and over the Island of Jamaica and its Dependencies.

Whereas it is enacted by subsection 1 of section 3 of the Stamp Issues (Cancellation) Law, Chapter 367, that notwithstanding anything in any other Law contained the Governor at any time by Proclamation may declare that any issue of stamps shall cease to be valid and in such Proclamation may provide for the cancellation of such issue:

Now, THEREFORE, I, JOHN MONTAGUE STOW, Companion of the Most Distinguished Order of Saint Michael and Saint George, Acting Captain-General and Governor-in-Chief in and over the Island of Jamsica and its Dependencies, in exercise of the powers conferred on me by subsection 1 of section 3 of the said Law, do hereby PROGLAIM AND MAKE KNOWN that as from the date on which this Proclamation shall come into force as hereinafter provided:—

- (a) all postage stamps of this Island issued in commemoration of the University College of the West Indies the denominations whereof are 2d. and 6d.,
- (b) all postage stamps of this Island issued in commemoration of the First Caribbean Jamboree 1952 the denominations whereof are 2d. and 6d.,
- (e) all postage stamps of this Island issued during the reign of His Majesty King George VI the denominations whereof are ½d. of the colour green, Id. of the colour carmine and 3d. of the colour blue

shall cease to be valid and the issue of all such stamps shall be and is hereby cancelled.

This Proclamation shall come into force on the first day of March, 1958.

Given under my hand and the Broad Scal of Jamaica at King's House this twenty-fourth day of August in the year of Our Lord one thousand nine hundred and fifty-seven, in the sixth year of the Reign of Her Majesty Queen Elizabeth II.

In exercise of the powers conferred upon the Governor in Council by section 7 of
the Post Office Law, the following Order made on the 30th day of August, 1957, by
the Postmaster General under subsection (2) of section 7 of the Post Office Law, is
hereby approved:—

- This Order may be cited as the Post Office (British Postal Orders) (Rates of Poundage) Order, 1957.
- 2. From and after the 1st day of October, 1957, British Postal Orders shall be subject to the following rates of poundage—

for each Postal Order at 6d. ... ... ... ... ... ... 2d. for each Postal Order at 1/- ... ... ... ... ... ... ... ... 2½d. for each Postal Order at 1/6, 2/-, 2/6, 3/-, 3/6, 4/-, 4/6, 5/- 3½d. for each Postal Order at 7/6, 8/-, 10/- ... ... ... ... ... ... 6d.



THE POST OFFICE (AMENDMENT) REGULATIONS, 1957

In exercise of the powers conferred upon the Governor in Council by section 7 of the Post Office Law, the following Regulations made on the 1st day of October 1957, by the Postmaster General under section 7 of the said Law is hereby approved:—

- 1. These Regulations may be cited as the Post Office (Amendment) Regulations, 1957, and shall be read and construed as one with the Post Office Regulations, 1941, hereinafter referred to as the Principal Regulations.
- 2. Regulation 2 of the principal Regulations is hereby amended by inserting therein, next after the definition of "commercial paper article", the following definition:—
  - "" "express delivery article" means an inland postal article intended to be delivered from the office of destination to the addressee by special messenger;".





"Special 23A. (1) Every express delivery article shall comply with the conditions following conditions—

conditions as to express delivery articles.

(a) the word "express" shall be marked in bold letters on the upper left-hand corner of the address side;

(b) the weight of the article shall not exceed seven pounds;
(c) the office of destination shall be in one of the following areas, that is to say—

- (i) the Urban and Suburban Districts of the parishes of Kingston and Saint Andrew as defined and described in the Second Schedule to the Kingston and Saint Andrew Corporation Law;
- (ii) Montego Bay; (iii) Mandeville;
- (iv) Spanish Town;
- (v) May Pen.
- (2) Express delivery articles shall be delivered on any day, other than a Sunday or a Public General Holiday, between the hours of eight o'clock in the morning and eight o'clock in the evening, and may be delivered on a Public General Holiday during such hours as the office of destination may be open.
- (3) Nothing in the provisions of this regulation shall be construed as exempting express delivery articles from any other provision in these Regulations.".
- 4. These Regulations shall come into operation on the 1st day of December, 1957.

THE POST OFFICE (FEES FOR EXPRESS DELIVERY) ORDER, 1957

In exercise of the powers conferred upon the Governor in Council by section 7 of the Post Office Law, the following Order made on the 1st day of October 1957, by the Postmaster General under section 7 of the said Law is hereby approved:—

- 1. This Order may be cited as the Post Office (Fees for Express Delivery) Order, 1957, and shall come into operation on the 1st day of December 1957.
- 2. In this Order the expression "express delivery article" has the meaning assigned to it by the Post Office Regulations, 1941 (as amended by the Post Office (Amendment) Regulations, 1957).

3. The following fees shall be paid for an express delivery article in addition to any postage chargeable thereon under the Post Office Law—

- (a) a fee of sixpence, which shall be pre-paid; and
- (b) where the point of delivery is more than one mile from the office of destination an additional charge for porterage (which shall either be pre-paid or be paid by the addressee) at the following rates—
  - (i) sixpence for every mile beyond the first mile from the office of destination where the entire distance does not exceed three miles;
  - (ii) one shilling for every mile from the office of destination to the point of delivery where the distance exceeds three miles.
