Postal rates to Cayman

Postal rates to the Cayman Islands are 3d for all letters and 2½d. for postcards as from August 10, an amendment to the Post Office Law published in the Jamaica Gazette Supplement on Wednesday, states.

The Postmaster General, Mr. F. O. Rousseau, said yesterday that the amendment was necessitated by an error in the postal rates published in April 1959. According to these, air letters to the Caymans cost 2½d., while surface letters cost ½d. more. This irregularity had to be corrected, and now both rates are the same. Mr. Rousseau said that mail is sent to Cayman either by plane or ship, depending on which travels first.

THE STAMP ISSUES (CANCELLATION) LAW (Cap. 367)

It is hereby notified for general information that by Proclamation published in the Jamaica Gazette Supplement (Proclamations, Rules and Regulations) of the 14th day of December, 1961, the postage stamps described in the Schedule hereto have been invalidated with effect from the thirty-first day of December, 1961, under the provisions of section 3(1) of the Stamp Issues (Cancellation) Law, Chapter 367.

2. Attention is also invited to the fact that under section 4 (2) of the Law, any person who is in possession of any unused stamp, the issue of which has been cancelled by this Proclamation, may within six months from the date of the coming into force of the Proclamation, that is within six months from the thirty-first day of December, 1961, apply to any Post Office concerned to have such stamp exchanged for, and replaced by a valid stamp, or valid stamps, of equal value.
