THE POST OFFICE LAW

(Cap. 301)

THE POST OFFICE (RATES OF POSTAGE) (AMENDMENT)
(No. 3) ORDER, 1963

In exercise of the powers conferred upon the Postmaster General by subsection (2) of section 7 of the Post Office Law, the following Order is hereby made with the approval of the Minister:—

- 1. This Order may be cited as the Post Office (Rates of Postage) (Amendment) (No. 3) Order, 1963, and shall be read and construed as one with the Order made by the Postmaster General under the Post Office Law, 1941, and published in the Jamaica Gazette Supplement of the 28th day of May, 1942, at pages 245 to 255 inclusive (hereinafter referred to as the principal Order) and all amendments thereto.
- 2. The section of the Schedule to the principal Order headed "(XII) Overseas Parcel Rates" is hereby amended in the following respects—
 - (a) by the deletion from the columns headed "Postage on parcels not exceeding in weight—11th, 22th" and opposite the words "Haiti (Republic of)" of the figures "12/5" and "14/2" and the substitution therefor of the figures "12/3" and "14/-", respectively;
 - (b) by the insertion in the column headed "Postage on parcels not exceeding in weight—22 ib" and opposite the word "Seychelles" of the figures "21/-";

(c) by the deletion from the column headed "Postage on parcels not exceeding in weight—3th" and opposite the word "Yugoslavia" of the figures "12/1" and the substitution therefor of figures "12/6".

THE SUGAR (RESERVE FUNDS) LAW

(Cap. 373)

THE SUGAR (RESERVE FUNDS) (DEPUTATION OF MINISTER) ORDER, 1963

In exercise of the powers conferred upon the Prime Minister by section 10 of the Sugar (Reserve Funds) Law, the following Order is hereby made:—

- 1. This Order may be cited as the Sugar (Reserve Funds) (Deputation of Minister) Order, 1963.
- 2. The Minister of Labour is hereby deputed to perform the duties and exercise the powers (including the power to make regulations other than orders under section 5 of the Law) which are conferred or imposed by the Sugar (Reserve Funds) Law upon the Minister charged with the responsibility for the subject of the Sugar Industry so far as such duties and powers relate to the Sugar Industry Labour Welfare Fund.

THE INDUSTRIAL INCENTIVES LAW, 1956 (Law 45 of 1956)

THE INDUSTRIAL INCENTIVES (APPROVED PRODUCTS) (SODIUM AND CALCIUM PRODUCTS)
ORDER, 1963

In exercise of the powers conferred upon the Minister by section 3 of the Industrial Incentives Law, 1956, the following Order is hereby made:—

- 1. This Order may be cited as the Industrial Incentives (Approved Products) (Sodium and Calcium Products) Order, 1963.
- 2. The following products of manufacture are hereby declared to be approved products for the purpose of the Industrial Incentives Law, 1956—

Sodium Carbonate, sodium bicarbonate, sodium hydroxite, calcium chloride.
