REVOCATION OF THE KINGSTON AND SAINT ANDREW CORPORATION HACKNEY CARRIAGE REGULATIONS (APPOINTED DAY) NOTICE

In exercise of the power conferred upon the Minister by section 189 of the Kingston and Saint Andrew Corporation Law, the following notice is hereby given:

- This notice may be cited as the Revocation of the Kingston and St. Andrew Corporation Hackney Carriage Regulations (Appointed Day) Notice.
- The 2nd day of November, 1967 is hereby appointed as the day on which the revocation of the Kingston and Saint Andrew Corporation Hackney Carriage Regulations shall come into operation.

THE POST OFFICE LAW (Cap. 301)

THE POST OFFICE (AMENDMENT) (No. 2) REGULATIONS, 1967

In exercise of the powers conferred upon the Postmaster General by section 7 of the Post Office Law, the following Regulations are hereby made with the approval of the Minister:—

- 1. These Regulations may be cited as the Post Office (Amendment) (No. 2) Regulations, 1967, and shall be read and construed as one with the Post Office Regulations, 1941 (hereinafter referred to as the principal Regulations) and all amendments thereto.
- 2. Paragraph 1 of regulation 2 of the principal Regulations is hereby amended by deleting the definition of "sample article" and substituting therefor the following—
 - " "sample article" means-
 - (a) any postal article posted in the Island which consists of or contains bona fide trade samples of goods or articles or merchandise not for sale, and contains nothing else except printed matter; or

(b) any tube of serum, vaccine, or medicine which is difficult to obtain and urgently required, if such article is sent in the public interest by a laboratory or institution which is officially recognized,

indelibly marked "Free Sample" on the article or on the packing thereof if such article is inseparable from the packing, and the words aforesaid shall also be written on the lefthand space above the address of the article;".

- Paragraph (1) of regulation 15 of the principal Regulations is hereby amended in the following respects—
 - (a) by deleting therefrom sub-paragraph (b) and substituting therefor the following—

"(b) it shall be necessary for postcards, other than picture postcards of private manufacture, to bear on their face the word "Postcard" or its equivalent in another language;

(b) by adding next after sub-paragraph (g) (iii) the following sub-paragraph

as sub-paragraph (h)-

"(h) reply-paid postcards shall bear on the front of the first half thereof the words "Reply-paid postcard" and on the second half the words "Reply postcard.".

4. The proviso to paragraph (1) of regulation 17 of the principal Regulations is hereby amended in the following respects—

(a) by deleting all the words commencing with "Provided that" and ending with the words "solely to the article" and substituting therefor the following—

" Provided that a person may, by any process, show on such printed paper article—

- "(1) (a) the name and address of the sender and the addressee with or without showing the status, profession and style of such sender and addressee; the place and date of despatch of the article, and the serial or registration number referring solely to the article;";
- (b) by deleting from the end of sub-paragraph (1) (h) the comma and all the words appearing immediately after the words "separate sheets" and substituting therefor a semi-colon; and
- (c) by deleting from the end of sub-paragraph (1) (k) the comma and all the words appearing immediately after the words "expression of regard" and substituting therefor a semi-colon.
- 5. Paragraph 4 of regulation 19 of the principal Regulations is hereby deleted and the following paragraph substituted therefor—
 - " (4) There shall be no writing in or upon any sample article or in or upon the cover thereof, except an indication, outside or inside the article and, in the latter case, on the sample itself or on a special sheet of paper referring to such sample the following particulars—
 - (a) the name and address of the sender and the addressee;

(b) the manufacturer's or trade mark;

- (c) a reference to exchange of correspondence between the sender and the addressee;
- (d) a short note referring to the manufacturer and to the person supplying the goods or concerning the person for whom the sample is intended;
- (e) the serial or registration numbers, prices, and any other notes relating to the essential elements of such prices;

(f) the weight, volume and size of the goods; and

- (g) the quantity of goods available, and such other particulars as may be necessary to determine the source and the character of such goods.".
- 6. Regulation 21 of the principal Regulations is hereby amended by adding next after paragraph (3) the following paragraph as paragraph (4)—
 - " (4) Small packets shall bear in bold letters on the front thereof the expression "Small Packet" or the equivalent of such words in a language

of the country of their destination, and the name and address of the sender of such packets shall be written on the outside thereof and such sender may enclose therein an open invoice reduced to its essential elements and a copy of the address of the article with a note of his address.".

- 7. Regulation 22 of the principal Regulations is hereby amended by adding next after sub-paragraph (i) (d)—
 - "(i) (d) Letters bearing writing used by the blind and posted unsealed, and sound records and special paper intended solely for the use of the blind, and plates bearing characters of writing used by the blind may be sent as literature for the blind:

Provided that such articles are sent by or addressed to an institute for the blind which is officially recognized in that behalf.

- 8. The proviso to regulation 83 of the principal Regulations is hereby amended in the following respects—
 - (a) by deleting from paragraph (c) the words "His Majesty's" and substituting therefor the words "Her Majesty's";
 - (b) by deleting from paragraph (d) the words "King's enemies" and substituting therefor the words and semi-colon "Queen's enemies;"; and
 - (c) by adding next after paragraph (d) the following paragraph as paragraph (e)—
 - "(e) in the case of subsequent discovery of an insured parcel the contents of which are found to be of a lesser value than the amount of indemnity paid, the sender of such parcel shall re-imburse the amount of indemnity so paid on the return of the insured parcel without prejudice to the consequences arising from any fraudulent insurance of such parcel."
