#### THE STAMP DUTY LAW (Cap. 366)

THE STAMP DUTY (INCREASE OF DUTIES) (NO. 2) ORDER, 1968

In exercise of the powers conferred upon the Minister responsible for Finance by section 3A of the Stamp Duty Law, the following Order is hereby made: —

1. This Order may be cited as the Stamp Duty (Increase of Duties) (No. 2) Order, 1968.

2. The Schedule to the Law is hereby amended in the following respects-

 (a) by deleting under the heading "Bills of Exchange and Promissory Notes (Inland)" the item "Bills of Exchange payable on demand......£0 0 3" and substituting therefor the item "Bills of exchange payable on demand......£0 0 4";

3. The new rate specified at paragraph 2(a) will apply to a Bill of Exchange payable on demand which is either—

- (i) drawn on or after 17th April, 1968, or
- (ii) drawn before 17th April, 1968, but presented for payment after 30th April, 1968, to the person on whom it is drawn.

Where a Bill of Exchange payable on demand is drawn upon paper stamped before 17th April, 1968, the additional duty of 1d may be denoted by means of adhesive stamps.

4. The new rates specified at paragraphs 2(b) and (c) will apply to any instrument executed on or after 17th April, 1968.

5. The Stamp Duty (Increase of Duties) Order, 1968 is hereby revoked.
