THE POST OFFICE LAW

(Cap. 301)

THE POST OFFICE (AMENDMENT) (No. 2) REGULATIONS, 1968

In exercise of the powers conferred upon the Postmaster General by Section 7 of the Post Office Law, and of every other power hereunto enabling, the following Regulations are, with the approval of the Minister, hereby made:—

- These Regulations may be cited as the Post Office (Amendment) (No. 2) Regulations, 1968, and shall be read and construed as one with the Post Office Regulations, 1941, (hereinafter referred to as the principal Regulations) and all amendments thereto.
- Regulation 153 of the principal Regulations is hereby amended by inserting therein next before the word "British" the words "Jamaica and".
- 3. The principal Regulations are hereby amended by inserting therein next after regulation 153 the following as regulation 153A—

"Jamaica postal orders, payable at all post offices in Jamaica, shall not be payable abroad and shall not be valid for the remittance of funds to any destination outside of this Island".

- 4. Paragraph (1) of regulation 156 of the principal Regulations is hereby amended by inserting next after the words "sender of a" the words "Jamaica or a".
- 5. Regulation 157 of the principal Regulations is hereby amended by deleting therefrom the words "Inland" and "three" and substituting therefor the words "Jamaica" and "six".

Regulation 161 of the principal Regulation is hereby amended by deleting therefrom the words "an inland" and substituting therefor the words "a Jamaica".

THE POST OFFICE (JAMAICA POSTAL ORDERS) (RATES OF POUNDAGE) ORDER, 1968

- 1. This Order may be cited as the Post Office (Jamaica Postal Order) (Rates of Poundage) Order, 1968.
